#### **Summary:**

Increase in referrals from the previous school year, reflected in how we are capturing concerns raised through My Concern. There is an increase in MASH referrals from wider professionals (police, A&E etc). Haringey social care have increased and widened invites to strategy meetings, DSL's have attended an increase in these meetings this school year.

Improved communication with social care teams regarding outcomes, although still room for improvement. Time spent with follow up regarding outcomes of child and family assessments.

Child on child incidents addressed through behaviour concerns raised and monitored through Red slips. This is linked to the behaviour policy and safeguarding policy. Child on Child issues related to friendship, sexualised behaviour, online behaviours and bullying issues. All issues raised address and parents/ carers informed.

Information communicated to upper junior parents in regards to social media misuse and issues brought into to school. Further work to be planned to support parents regarding managing social media issues at home.

#### **Ofsted Infants:**

Bounds Green Infant school was inspected in March 2023. As in all inspections the safeguarding is scrutinised by the lead inspector. She undertook SCR checks, interview with DSL and safeguarding leads, discussions with pupils, staff and feedback from parent survey questionnaires and any other observation during the inspection. Safeguarding was judged to be effective:

'The arrangements for safeguarding are effective.

Leaders ensure that all staff take responsibility for keeping pupils safe. Staff know and use the procedure for reporting any concerns. The training they receive equips them well to spot the signs of pupils who are at risk of harm. The school ensures that pupils and their families receive support that they need. Leaders work effectively with external support agencies. They make sure actions are timely.

Pupils are taught how to keep safe. This includes staying safe using technology and not speaking with strangers. Pupils said they would speak with a trusted adult about any worries.' Bounds Green Infant School Report May 2023.

#### Relationships and Sex Education (RSE):

All year groups from Reception Class to Year 6 taught their block of learning for Sex Education and the Relationship part of the learning. Teachers follow the agreed plans adopted from the Christopher Winters Project.

The school was contacted by 12 families requesting to view and discuss the material. 5 of which opted out of the Sex Education element, but understood that they were unable to withdraw their child from the Relationship element

We also started the start of Pride Month, through phase assemblies were we all celebrated diversity and difference. Some class followed on with further work in their PSHE time. Further work and planning required to extend the celebration of Pride month 2024. Which will be part of next year's planning for the PSHE working group.
