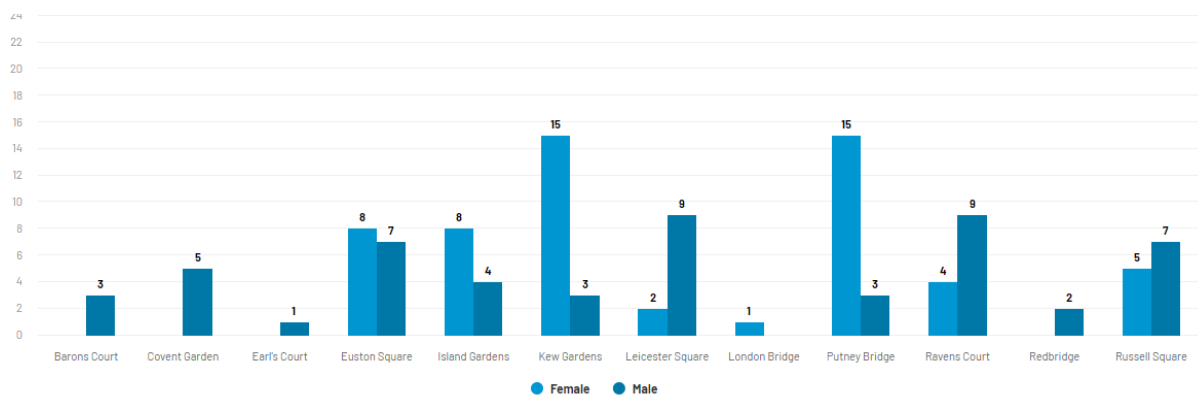

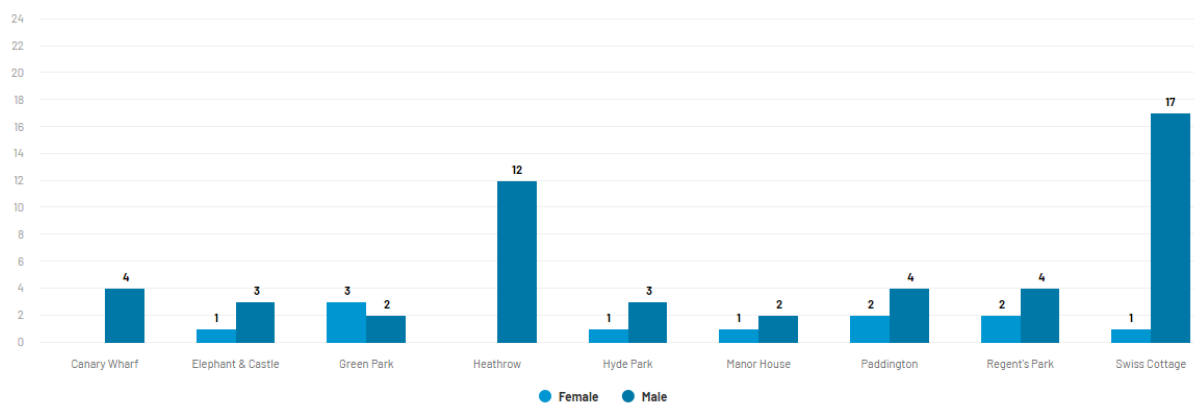

Staff continue to use 'My Concerns' system effectively. Concerns often related to the same child for a period until issues are addressed. Class teachers have now been added to the team for a child in their care and regularly update the child chronology directly (this has helped with monitoring).

2 school referrals to MASH since January 2022 supported by evidence collected through My Concern, in addition to this alerts from MASH have been easily shared with appropriate staff.

Ofsted:

The junior school completed a successful Ofsted inspection in March 2022. The lead inspector was very complimentary in regards to the children in year 6 he spoke with as part of his pupil discussion around 'peer on peer', bullying and behaviour. He was very impressed with the way the children spoke honestly but also understood what they should do and how the school can help to keep them safe.

Our detailed conversation with the lead inspector also supported his decision on safeguarding at school. We presented case studies, referrals, peer on peer logs and actions taken to keep children safe.

Safeguarding

The arrangements for safeguarding are effective. There is a strong safeguarding culture. Leaders carry out all required checks when recruiting new staff. Regular training ensures that staff know what to do if they have concerns. Leaders know pupils’ families well. They engage swiftly with outside agencies to provide help and support for vulnerable pupils.

Pupils’ lessons in computing help them learn how to stay safe when online. Leaders have provided specific workshops on dealing with peer-on-peer abuse, and how to discuss their emotions and feelings. Pupils are articulate and know how to respond to any harassment or name-calling. They say they are learning how to be resilient and confident.

PANTs:

Early Years team have launched the NSPCC PANTs campaign, linked in through Haringey Safeguarding board.

PANTs, introduces children to the underpants rule and how to keep themselves safe. The NSPCC resources are designed to help parents and school staff talk about sexual abuse. Information on this was shared with parents via their newsletter. This will be revisited in the summer term.

PSHE:

The summer (i) focus in PSHE is consent, classes have explored the themes of consent and developed a better understanding in the context of online, relationships etc. PSHE themes are delivered through the weekly assemblies delivered by Helen and follow up session completed in class.

The PSHE curriculum reflects aspects of safeguarding, behaviour and attitudes. The school PSHE working group continues to develop the curriculum to reflect the current issues and a program that will support and develop Bounds Green pupil to challenge, be resilient and make good choices.
